

DEAN'S ORDER No. 4/2022

on the amount of tuition fees, fees and payments associated with study and fees associated with the awarding of scientific and pedagogical degrees at the Faculty of Civil Engineering of the University of Žilina in Žilina in the academic year 2022/2023

Article 1

Introductory provisions

1. The purpose of issuing this order is to determine tuition fees, fees and payments associated with study and fees associated with the awarding of scientific and pedagogical degrees in the academic year 2022/2023 at the Faculty of Civil Engineering of the University of Žilina in Žilina (hereinafter referred to as 'FCE UNIZA').

Article 2

Determination of the amount of tuition fees, fees and payments associated with study and fees associated with the awarding of scientific and pedagogical degrees at the Faculty of Civil Engineering of the University of Žilina in Žilina in the academic year 2022/2023

- 1. Pursuant to the provisions of Directive Žilina University of Žilina No. 116 and its appendices in the current wording, in the academic year 2022/2023 tuition fees, fees and payments associated with studies and fees associated with the awarding of scientific and pedagogical degrees are set according to tables 1 to 6.
- 2. Fees are paid by transfer order to the account **SK59 8180 0000 0070 0026 9896** or postal order. When paying, it is necessary to indicate the relevant variable symbol (v. s.). When paying, it is always necessary to state the name of the payer. All amounts are stated in euros (EUR).

In the tables, the degree of study and the form of study are indicated by an abbreviation:

- Bc.: 1. degree of higher education bachelor's degree,
- Ing.: 2. degree of university studies master's degree,
- PhD.: 3. university degree doctoral studies,
- D: full-time form of study,
- E: part-time form of study.

3. Documents issued free of charge according to Act no. 131/2002 Coll. on universities and on

the amendment of certain laws as amended (hereinafter 'the law'):

- a) statement of study results (in accordance with § 67 paragraph 5 letter a) law),
- b) university diploma,
- c) certificate of state examination,
- d) supplement to the university diploma.
- 4. Documents issued when registering for studies are issued free of charge.
- 5. Documents required when sending UNIZA students on exchange stays abroad are issued free of charge. The applicant must actively participate in their preparation.
- 6. For a reduced fee of 50% of the fees listed in Table 5, they are issued to applicants who are UNIZA students:
 - a) copies of study documents in the event of their theft (it is necessary to document a police investigation),
 - b) documents to which the reduced fee does not apply, but whose processing into the final form (including possible translation and printing) was ensured by the applicant himself.

Article 3

Final provisions

- 1. The order of the dean of FCE UNIZA becomes valid on the day of signature. It takes effect on September 2022.
- 2. The order of the dean of FCE UNIZA no. 9/2021 of June 15, 2021 is cancelled.
